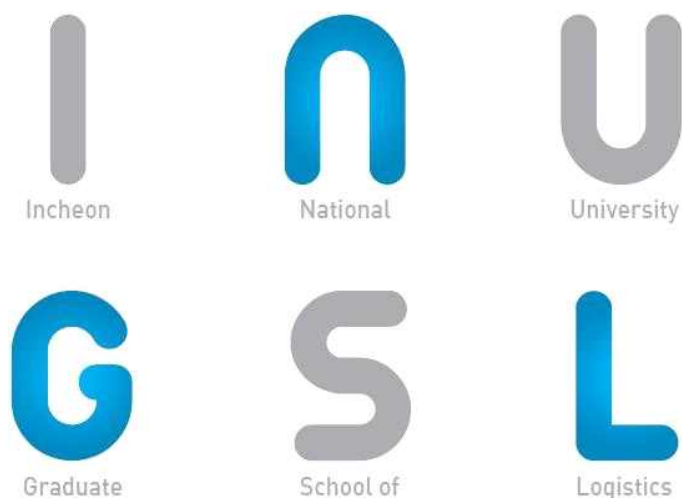

2026 Fall Admission of Postgraduate Programmes

1. Programmes

1. MSc Programme (Master of Science in Logistics)

- Admission
 - 00 students(Foreign Nationality)
- Major
 - Study of Logistics Management
 - Study of Convergence Logistics Systems

- ※ Under the Korean Education Act, the number of foreign students selected is not limited.
- ※ Major can be selected and changed after admission by a student.
- ※ Applicant can contact one of the professors at the GSL in advance to select a supervisor, otherwise the supervisor can be selected after admission (i.e. the end of first semester) by a student.

2. Doctoral Programme (PhD in Logistics)

- Admission
 - 00 students(Foreign Nationality)
- Major
 - Study of Logistics Management
 - Study of Convergence Logistics Systems

- ※ Under the Korean Education Act, the number of foreign students selected is not limited.
- ※ Major can be selected and changed after admission by a student.
- ※ Strongly recommend that an applicant needs to contact one of the professors at the GSL in advance to select a supervisor.
- ※ **Note: According to the Korea Information and Communication Act, foreign residents (both Koreans and foreigners) cannot apply the postgraduate programmes through the Uni's admissions system, please contact the admission office (uigsl@inu.ac.kr) and go through further application process.**

3. Eligibility to apply

Academic requirements for Foreign Applicants

1. MSc Programme (Master of Science in Logistics)

- Applicants that have completed (or expected to complete) a 4 year Bachelor's degree program, either in Korea or foreign universities overseas.
- Applicants who hold an equivalent qualification recognized by the Korean Ministry of Education.
- For special admission, applicants must have an average grade point average of 3.0 or higher in all college years or have more than 3 years of experience in logistics and SCM-related fields.
- Applicants can choose the major(among two studies) regardless of your bachelor's major.

2. Doctoral Programme (PhD in Logistics)

- Applicants that have completed (or expected to complete) a Master's degree (from universities that offer 4 year Bachelor's degrees)
- For special admission, applicants must have an average grade point average of 3.0 or higher in all college years or have more than 5 years of experience in logistics and SCM-related fields.
- Applicants can choose the major(among two studies) regardless of your bachelor's or master's degree major.

3. Additional requirements

- 1) Test of Proficiency in Korean (TOPIK) : Level 3 or higher (Level 4 or higher must be obtained before applying for graduation thesis), or;
- 2) Official English Certification : TOEFL 550, IBT 80(or New iBT 4.0), IELTS 5.5, NEW TEPS(297), TOEIC 700 or higher, or;
- 3) Special recommendation letter from dean/president and professor of INU Graduate School of Logistics (if applicable).

- All submitted documents must be original documents (or original notarized documents translated into Korean/English). Documents **other than Korean or English must be translated into 'Korean' and notarized.**
- The application form shall include work experience, journal publications, conference presentations, language proficiency test recognized internationally, etc. Original documents must be submitted to prove the achievements.

- ※ Applicants who have obtained (or expected to obtain) a bachelor's or higher outside of China may be required to provide the additional documents.
 - Applicants who have obtained a degree in the United States must receive a [Confirmation of Accredited University] by the Korean-American Educational Commision (Tel. 02-3275-4000).
 - Applicants who have obtained a degree in Japan, must obtain a [Seal Certification] from the Embassy's Consular Section (Tel. 02-739-7400).
 - Applicants who have obtained a degree from another country must provide one of the following documents:
 - [Confirmation of Accredited University] from the Embassy of the respective country.
 - [Confirmation of Foreign Educational Institution] from the Korean consulate in that country.
 - [Apostille Certification] from the Government Authority of that country.

5. Selection Method : Document Screening and Interview

- Document screening: University or graduate school transcripts, work experience
- Interview: Evaluation of the applicant's character and qualities, motivation and enthusiasm for further study, degree of alignment with the major, knowledge in the field, and potential for academic development, among other criteria.

6. Application submission [After applying online, print out the application form and submit it with the required documents]

7. Application fee : 60,000 KRW

- Application Fee Payment: After submitting the admission application, the application fee must be paid through bank transfer to the virtual account number assigned to each applicant. (The payment can be transferred by the applicant or a third party)

* Foreign applicants must to attach a receipt as evidence of payment for the application fee.

8. Important Notice for Application

- Successful applicants will be notified through the official website of the Graduate School of Logistics and will not be individually informed.
- All documents must be originals or original copies (officially notarized copies). Any documents in languages other than Korean or English, must be submitted along with an official Korean translation.
- Submitted documents and application fee are non-refundable.
- The admission approval will be canceled if any submitted documents are found to be false or fraudulent (all fees paid, including tuition, will not be refunded).
- Please ensure not to mistype your information. In the event of admission cancellation due to incorrect contact details on the application form, the applicant is responsible and no objections can be raised for any reason thereafter.
- At the time of application, “expected graduates” are required to submit one copy each of their graduation certificate and academic transcript before the start of classes.
- New students are not allowed to take a leave of absence in their first semester (except in cases of military service leave or health reasons with a medical certificate attached).
- Any admission-related matters not specified in this guideline will be determined by the Graduate School Admissions Committee.
- International students must visit the local immigration office and apply for a Residence Card within 90 days of their entry into Korea.
- VISA issuance
 - Qualification: Studying Abroad (D2)
 - Applicant organization: Local Korean Embassy
 - Required documents
 - ① Original copy of the Degree certificate
 - Graduates of Chinese universities (including graduate schools) must submit a certificate of academic qualifications and degrees issued by the Chinese Ministry of Education's Academic and Degree Certification Center (<http://www.chsi.com.cn>) or a diploma certified by the Korean Consulate.
 - ② Admission Approval Letter
 - ③ Proof of funds
 - Certificate of deposit balance of the applicant or financial guarantor
 - ※ One original copy of a certificate of deposit balance in domestic or foreign banks (e.g., US dollars or Chinese yuan) equivalent to 20 million KRW
 - ※ Must be 20 million KRW or more based on the exchange rate on the certificate issuance date
 - ④ Photo (in color) for Visa issuance
